Kissimmee Utility Authority EV Vehicle & EV Charger Rebate Program Guidelines and Restrictions

- Must be an active KUA account holder and charger must be connected to KUA electric meter.
- Rebates are subject to change without notice, subject to approval and contingent upon fund availability.
- Random on-site verification of installed/purchased items may be performed prior to issuing rebate.
- All rebates will be issued in the form of a CREDIT on the customers account unless specified otherwise.
- Please allow 4 to 6 weeks for processing all rebate requests.

CUSTOMER INFORMATION

- All rebate supporting documentation (invoice/receipt) is due within 60 days of installation or purchase unless otherwise authorized.
- Maximum of one Vehicle Charging Station rebate per household.
- Charging station must be installed by a licensed electrical contractor.
- One rebate per vehicle. (limit 5 vehicles per household)
- Charging station install must meet all state and local codes.
- Vehicle must be registered to an address within KUA territory.
- Must have bill of sale/proof of purchase for Electric Vehicle.
- Customer agrees that Kissimmee Utility Authority shall have the sole right to obtain and retain ownership of, and to qualify for and receive the full benefit of any and all existing and future credits, certificates, benefits, environmental attributes, emissions reductions, offsets and/or allowances, however entitled, attributable to the installation and/or operation of the eligible equipment.
