Joe Hostetler, vice president of Finance & Administration explained this is to establish a deferred compensation plan board. KUA employees have the option to

invest some of their pay to ICMA and or Nationwide however, Mr. Hostetler advised that he cannot certainly say that ICMA and Nationwide are providing the best fund options at the lowest cost to the employees.

Mr. Hostetler advised that a consultant was brought in and an RFP process took place. Fiduciary First was selected and the first recommendation they made was to have a formal Board set up authorized by your governing body to oversee and make decisions on behalf of the employees. The Board will be made up of those on the Pension Board and they will develop a program to educate the employees.

Dr. Gant asked about the two plans. Mr. Hostetler advised that the 457 came from the City and when KUA broke off from the City the KUA Board also offered to the employees a 401a plan. Dr. Gant asked if the primary responsibility of this new Board will be to only recommend funds with the employee making the decision. Mr. Hostetler advised yes.
